III. WALK AUDIT FINDINGS AND DEBRIEF

- a. Riley presented her findings on the walk audit performed by AFL OE workgroup 6/25 and a walk audit performed with the Francis Parker school on 6/27.
- b. Common findings include: broken items/disorder, Inconsistent entrances, varying sidewalk conditions, lack of audible cues at crosswalks, and disturbances of daily life (houseless individuals, safety etc)
- c. During the 6/27 walk Riley and Rebecca used a custom audit tool sheet. The OE workgroup will consider adopting this option for future audits.
- d. Suggestions for future audits include: using the custom audit tool sheet, designating 1 recorder and one photographer to capture images and report to 311, gather more community partners, and vary locations.
- e. A discussion of meeting with a Metro Councilperson who may be a champion for change regarding accessibility to discuss findings was had. CW Betsy Ruhe was discussed as a good choice. Sophia will reach out to her to set up a meeting.
- f. Brainstorming for the next walk audit location provided the following suggestions: Poplar Level Rd/Trevilian Way, area surrounding the new Iroquois Senior living complex, Westport Rd (involve league of cities/mayor)
