In June, John Setzer came and spoke to us about the elements of training for first responders he felt were more important when it came to serving older adults, and the main focus of that was trauma & trauma responses from older adults, the commonality of it as well as what it looks like, and the need for first responders to have this knowledge & understanding when working with older adults. - Main points that came from the discussion were the group's idea of Fact Sheets & the starting topics being compassion, mental health & trauma. ii. Pam reviewed the Strategic Plan iii. Kelly presented to us what she has completed of the FR Fact Sheets covering compassion & empathy as well as older adult mental health (almost to completion). The group responded positively to the layout and content she presented. Kelly had resources she was unsure how to make accessible and the group suggested she use QR codes that FR could scan with their phones to use the assessment tools provided. iv. Discussion around Prepare to Care from AARP around how to share & or promote the curriculum, many people had suggestions.
